You represent and warrant to Trail Run Events (TRE), The UltraLadies Running Club (UL), the State of California (SCA), the City of Los Angeles (CLA), Mountains Conservancy Recreation Authority (MRCA), California State Parks (CSP), National Park Service (NPS) that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"). If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties.
